#### Eligibility

⇒ Admission will be allowed only to those applicants who have passed the qualifying examination at most two years prior to the year of admission i.e. Annual 2025/Annual & Bi-Annual 2024. However, in the departments where the numbers of applicants are less than the number of seats available; relaxation of one more year can be given i.e. 2023.

⇒ Candidate's age shall not exceed from 24 years, however, in the B.Ed. (2.5 Years/ 5<sup>th</sup> Semester) Programs age limit will be 26 years at the time of applying for admission.

#### ⇒ For Pharm-D/DPT:

Candidates with at least 60% marks in F.Sc. (Pre-Medical) are eligible.

#### ⇒ For BEMS:

Candidates with at least 50% marks in F.Sc. (Pre-Medical) are eligible.

#### ⇒ For BBA:

Candidates with at least 45% in Intermediate or its equivalent are eligible to apply for admission.

#### ⇒ For B.Ed. (1.5 Years):

Candidates holding other than Education degree i.e. MA/M.Sc./BS or its equivalent degree from any recognized institution, with at least 2<sup>nd</sup> division (for annual system) or CGPA (2/4) are eligible to apply for admission.

#### ⇒ For B.Ed. (2.5 Years):

Candidates holding other than Education degree i.e. BA/B.Sc./ADA/ADS or its equivalent degree from any recognized institution, with at least 2<sup>nd</sup> division (for annual system) or CGPA (2/4) are eligible to apply for admission.

⇒ **For B.Ed. (5<sup>th</sup> Semester):**

Candidates holding Education degree i.e. ADE from any recognized institution, with at least 2<sup>nd</sup> division (for annual system) or CGPA (2/4) are eligible to apply for admission. **Only 10 seats available in the morning program.**

⇒ **For LL.B. (4 Years):**

- Candidates holding Intermediate or its equivalent certificate/diploma from any recognized institution, with at least 2<sup>nd</sup> division (for annual system) or CGPA (2/4 C Grad) are eligible to apply for admission.
- Each applicant will have to qualify the LAT (Law Admission Test) conducted by HEC with **at least 50% marks for becoming eligible for the admission, as applied for.**
- ▶ Applicants who do not fulfill the academic prerequisites.
- ▶ Candidates who passed the qualifying examination in Bi-Annual 2025 will not be eligible for admission this year.

**How to apply**

- Each applicant must clearly specify the category (i.e., 'A' 'B' or 'C'). The details regarding each category and its breakup are given in the prospectus.
- Each candidate will have to generate online bank challan of Rs.3000/- (Non-refundable for admission processing fee) from University of Balochistan website and deposit the fee through any HBL online branch for admission processing fee.
- There are certain steps (as per given guidelines) to be followed carefully while filling the online Admission Form as there will be no change/edit option after submission of online admission form.
- Candidates seeking admission under category A will submit the admission form in hard copy (02 Sets with all relevant documents) in their respective Institute/Sub-campus within due date positively.
- Candidates applying for admission to the main campus under category B or C1, C2, C3 & C4 must submit their fully completed forms to the office of the Deputy Registrar (Students Affairs) by the specified due date. Similarly, candidates applying for admission to sub-campuses under categories C1, C3 & Professional Quota (for LL.B./Pharm-D only) (as defined in the prospectus) must submit their fully completed forms to the respective Sub-campuses.
- Candidate must enter same CNIC number while generating the online challan and application form.

**Important**

- ☞ Admissions in all disciplines will be granted on merit basis as per existing admission policy.
- ☞ Commencement of classes in afternoon/evening self-finance programs will be contingent upon the enrollment of at least 25 students in a class.
- ☞ Candidates who are willing to apply in morning/afternoon/evening should submit separate application forms for each.
- ☞ Students admitted on Self-Finance Basis will not be eligible for any financial assistance/scholarship/hostel facility.

- d) Two attested photocopies of Local / Domicile Certificate of applicant/guardian.
- e) Two attested photocopies of CNIC/computerized NADRA B-Form (each) of the applicant & his or her father/guardian CNIC photocopies. Without an applicant's CNIC/ computerized NADRA B-Form, no applicant will be entertained for admission.
- f) Two attested photocopies of character certificate from head of the Institution last attended.
- g) Affidavit(s) available in the prospectus on UGSO website is mandatory to be filled and signed by each applicant and countersigned by applicants' parent/guardian.
- h) Applicants will have to bring their original documents at the time of interview; otherwise, will not be considered for the admission, applied for.

- Service certificate (in original).

**Religious Minorities:**

- Shall submit an Affidavit (in original) duly attested by the Magistrate 1<sup>st</sup> Class and countersigned from the Head of Church/ Head of Quetta Hindu Panchayat/ Other (Specimen of Affidavit in prospectus Appendix-IA).
- 2 attested copies of parent CNIC.
- 2 attested copies of Birth Certificate.
- Service certificate (in original).

**Category C1:**

- Dependents of University of Balochistan Teachers/ Officers/ Employees shall submit an Affidavit (in original) duly attested by the Magistrate 1<sup>st</sup> Class and countersigned from the head of department/ institute/ centre/ section where the dependent (i.e. father/ mother/ brother/ sister/ spouse) is serving (Specimen of Affidavit in prospectus Appendix-II).
- 2 attested copies of guardian's (father/ mother/ brother/ sister/ spouse) CNIC.
- 2 attested copies of guardian's service card.

**Category C2:**

- Sports certificate(s) duly attested from the Sports Board Balochistan/Sports Board Pakistan.

**Category C3:**

- Disability certificate issued from the Balochistan Provincial Standing Medical Board Provincial Health Directorate.

**Criteria:**

1. Admission in all the programs shall be given as per University Policy.
2. Test/Interviews of the eligible candidates will be held in the concerned Institute/Sub-campus as per schedule given below:
3. The University would conduct departmental test and NTS where applicable.
4. Each applicant will have to qualify the Entry Test/ NTS with at least 50% marks for becoming eligible for the admission, as applied for.
5. If a candidate fails to make payments to admission dues up to the last date, his/her admission shall stand cancelled and the next on waiting list will be considered for admission. In such a case he/she cannot claim his/her admission; however, if seats were available in the concerned department, he/she will be given a chance to deposit the prescribed dues.
