- 2 Assignments of Similar Nature and Complexity 8,000,000 in Previous 05 Years
- Turn over of at least 23,000,000 PKR in 05 Subsequent Previous Years
- Presence in Active Tax Payer List
- Sales Tax Certificate
- The bidding firm must not be currently blacklisted by any procuring agency of Pakistan
- JV is not permissible
- Submission of the required Bid Security In case Bid Security is not found as required during financial evaluation the bidding firm shall be declared as ineligible and non-responsive
- Submission of the required Bidding document Fee
- The bidding firm must provide detailed datasheets for each of the following gas sensors and RF modules: Hydrogen Sulfide (H₂S) Carbon Monoxide (CO) Oxygen (O₂) Methane (CH₄) RF Wireless Modules
- The firm should provide the firmware/code for the supplied Sensors/equipment and the firm should also provide technical support in testing the equipment in underground mines.
- The firm must have a valid ISO 9001:2015 certification for its Quality Management System.
- Firm's Turn-over should be at least 23 million in last Three (05 OR 03) years.
