**IMPLEMENTATION OF BIOMETRIC ATTENDANCE SYSTEM FOR ALL TEACHING AND NON-TEACHING STAFF.**


In pursuance of the directives issued by the Government of Balochistan regarding mandatory implementation of Biometric Attendance in Public Sector Universities (PSUs), and with reference to the following correspondence:

- Home Department letter No. SO(Pol-I)1-4(Education)/2025/10259-68 dated 3rd December, 2025.
- Colleges, Higher & Technical Education (CH&TE) Department letter No. SO(Acad:)1-29/G-F.UNIV/2025/866 dated 9th December, 2025.
- CH&TE Department progress report letter No. SO (Acad:)1-29/G-F.UNIV/2025/55-59 dated 4th February, 2026.

It is hereby circulated for the information of all concerned that the Biometric Attendance System will fully be operational at the University of Balochistan, Quetta & its Sub-Campuses effective from the first week of March 2026. In order to ensure a seamless transition; the following registration schedule must strictly be followed:

- **Non-Teaching Staff:** The biometric data for the majority of non-teaching staff is already available; however, any employee who has not yet registered or whose data is missing is directed to complete his / her registration at the Office of the Deputy Registrar (T&D) UoB, Quetta not later than 27th February, 2026.
- **Teaching Staff:** Fresh biometric registration is mandatory for all the faculty members. Therefore, they are instructed to complete their registration process at the Office of the Deputy Registrar (T&D) UoB, Quetta by 6th March, 2026.

Please note that in compliance with the Government of Balochistan's requirements, the University is bound to submit consolidated monthly attendance report/s to the Colleges, Higher & Technical Education Department (CH&TE) GoB. Failure to mark attendance through the Biometric System may result in disciplinary proceedings in accordance with the E&D Rules of the University.
