Notification

In continuation of this office Notification No: REG/GEN:/160-15 Dated 11-03-2026 and in pursuance of Government of Balochistan, Colleges, Higher & Technical Education Department Notification No. SO/(ADMIN)3-109/CH&TE/2025/1233-43 dated 22-03-2026, and in view of the Pre-UFC meeting held on 17-03-2026 under the Chairpersonship of Hon'ble Pro-Chancellor / Provincial Minister for Higher and Technical Education, Government of Balochistan; It is hereby notified that the on-campus suspension of academic activities at University of Balochistan and its Sub-Campuses is extended till 31st March 2026.

However, all Deans and Chairpersons are directed to immediately arrange classes through online hybrid teaching Modes including (*Synchronous and Asynchronous*) till further orders. Therefore, the schedule and modalities of which shall be communicated and streamlined by the respective Chairpersons in-consultation with the Deans of the faculties and subsequently students must be informed through telephone, UoB website and/or social media platforms such as whatsapp etc to attend online classes and/or access the course material through UoB LMS (Learning Management System). In the said context the faculty must ensure to record their online classes and upload / share the link of lectures along with material to the students, for 24/7 accessibility. Consequently, any relevant support and facilitation will be provided by DIT office.

All academic and administrative Heads will determine that the Fifty percent (50%) of the staff and faculty shall attend the office on an alternate day basis, while the remaining 50% shall perform their duties from home, ensuring that official work does not suffer. The laboratories, ongoing research and other essential services shall be continued in routine.

All concerned are directed to ensure strict compliance with the above-mentioned instructions.

NOTE: *The Examinations, Tests, and Interviews already scheduled shall be conducted accordingly.*
